4. We may provide you with a FDD in hard copy or electronic format. If the FDD is furnished electronically, it will be provided in a Portable Document Format (PDF) file. You must use the Adobe Acrobat program in order to open and view this type of electronic file.
5. Upon receipt of the FDD, please complete and sign the final two pages of the document entitled “Receipt”. Once completed and signed, return the Receipt entitled “Our Copy” to the address indicated above.
6. It is recommended that you review our FDD with your attorney and business advisors.
